Voting will also take place live at the main entrance to the venue where the final pageant is being held. Votes will be counted and added to the total votes from the online voting.

4. Voters may vote for as many contestants as they choose and as many times as they choose.

5. One vote equals \$1.00 (US dollar) donation.

6. Voters must vote a minimum of five (5) votes or \$5.00 US dollars for any given contestant.
